### **Agenda:**

#### **1. Welcome and Approval of Minutes**

Chair, Alan Davidson, opened the meeting and welcomed everyone. The meeting agenda was circulated to all. Minutes from the previous meeting had been previously circulated to all committee members and were duly approved with the following corrections:

- Section 1 title - EGM should be removed
- Section 6 - There were 4 coffee mornings and not 6
- Section 6 - change "JW raised concern" to "JW stated"

#### **2. Planning Matters**

Proposed development at Kings Drive has been dismissed.

At the Westway Retail Park a mixed use planning development is expected to be submitted before the end of the year.

### 3. Police Report

16 crimes reported to 7 December 2018, none in Dullatur. One incident did take place in Dullatur but was not reported to police.

Alan Masterton informed the committee that Police Ops in North Lanarkshire would be focusing on tackling a number of crimes in the coming weeks from domestic violence to drug related crime.

### 4. Other NLC matters

Cllr Masterton gave an update on some items raised at the last meeting:

- Willie Thomson met with Margaret Smillie to discuss the placement of the boulders to prevent access between Victoria Terrace and Prospect Road alongside the Bunny Hop. Agreement was reached to place the boulders to the NE of the gate allowing Network Rail access to the train track via Prospect Road.

### 5. Financial Report

Margaret Kennedy gave the following update as of 23 November:

Balance in main account = £1163.49

Balance in maintenance account = £1804.02 with £20 from the Terriers Club, £285 from the St Andrews Night and £275 from the Toddlers still to be banked.

Dance class will stop 5 December. £48 still owing. Key has been returned.
